To Give donation / help to other organisations / individuals with objects of public service.

To draw, make, accept, endorse, discount, excuse, negotiable transfer and issue bills of exchange bills of lending promissory notes, warrants, debenture and all other negotiable and transferable instruments and securities including letter of indemnity in connection with objects of trust.

To open an account or accounts with any banks or bank in the name of trust and to operate such account or accounts what is indebit or in credit to give all appropriate instructions to the banker / bankers concerning the operation of such account or accounts provided that the banks accounts shall be operated by office bearer trustee the president. Secretary, treasurer and any two of above named shall be imperative for any withdrawal from the bank.

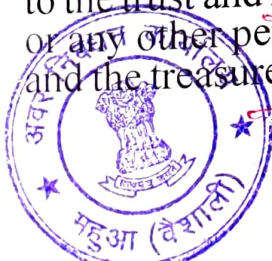

The treasurer shall make payment against proper receipt or receipts according to the expenses and disbursement authorised to be made by the secretary. the treasurer shall cause the true account to be kept of the sum of money received and expenditure by the trust and the matter in respect of which such receipts and expenditure take place and of the agents of the trust.
